Points of The Stewards:

Procedure:

- Following a report made by The Race Director in Doc. 1 upon the request of Car 39 driven by Andrea Dell'Ovo (officially made at 06:49 on 20/02/2022), The Stewards did validate the race final classification and highlighted the problem which was subject of the drivers' report.

Conclusions of the investigation:

- The Driver apparently lost 1 lap on the timing systems and therefore was classified 12th instead of 6th.
- There was a breach of Article 28.2 of The Code due to a game bug.

Decision of The Stewards:

- The race final classification is successfully modified by applying Article 28.2).
- In the next page, there is the race final classification for the ATOM F1 8th Bahrain Grand Prix.
